NBC Definitions

- Not registered – boats not licenced at the time of boat count
- MAC (Mooring Awaiting Confirmation) – licenced but information not yet provided as to whether boat has a home mooring or not
- BIN boats that have not been identified and no further sightings
- Trailable – boats that are removed from the water after use
- Other navigations – boats are based on other navigation authority waterways, for example the Environment Agency waters and are on Canal & River Trust waters on a gold or short-term licence
- London National Boat Count covers the following waterways; Grand Union (Springfield to Brentford), Paddington Arm, Slough Arm, Regents, Hertford Union, Limehouse Cut, River Lee and River Stort

National Boat Count and other Boat sightings

- The March 2020 national boat count recorded 229 fewer boats in the than the 2019 NBC, however due to flooding and Covid-19 not every part of the London boat count was completed fully.
- Looking at other boat sightings (excluding boats on a home mooring) in Jan/Feb and Sept 2019 and 2020 there are more boats sighted.
- Jan/Feb 2019 - Jan/Feb 2020: +364 boats sighted (all boats)
- September 2019 – September 2020: +1542 boats sighted (all boats)
- Jan/Feb 2019 – 9421 (CC) Jan/Feb 2020 – 10,123 (CC) + 702
- September 2019 – 4742 (CC) September – 5889 (CC) + 1147
